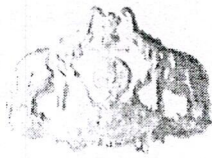


**CIRCULAR**

**Sub:- Timely action on the judgments/orders of Judicial/quasi judicial forums-reg.**

It has come to notice that the judicial/quasi judicial forums have come down heavily on various departments for non compliance of its judgments/orders in time and in its proper perspective. Recently, the Kerala Administrative Tribunal in its order dated 01.10.2021 in Contempt petition CP 44/2020 in OA 1695/2018 has expressed displeasure in non-compliance of its orders issued to various Governmental authorities observing that neglect to obey orders will be viewed seriously and those who are responsible are liable to be proceeded under the Contempt of Courts Act read with the relevant Rules.

A lively relationship between the Judiciary, Executive and Legislature is inevitable as far as a democratic State is concerned. The orders and directions passed on the judicial side are not seen complied with in a substantial number of cases. Compliance/Appeal follows only on filing of contempt petitions/adverse remarks and that too after notice being issued to the concerned pointing out non-compliance. Such type of practices needs to be viewed seriously and that the adverse remarks/consequences arising there from are to be avoided by the officials concerned. In future, effective steps should be taken to ensure timely action in compliance of the judgments/orders or for filing appeal against the same.

All Additional Chief Secretaries/Principal Secretaries/Secretaries and Special Secretaries should ensure that the above instructions are strictly followed in their departments including the line departments.


