**CIRCULAR**

The Indian Council of Forestry Research and Education is an Autonomous Council of the Ministry of Environment, Forests & Climate Change, Government of India, with its Institutes at Dehradun, Jabalpur, Bengaluru, Jorhal, Jodhpur, Coimbatore, Shimla Ranchi, and Hyderabad.

- The following posts in the ICFRE's Institutes and Centres are available for filling up on deputation basis at the level of Conservator of Forests (CF) and Deputy Conservator of Forests (DCF). The posts of CF are to be filled up through IPS officers in the Level-13 and Level-13(A) of 7<sup>th</sup> CPC Pay Matrix. The Chief Conservator of Forests (CCF) in the Level-14 of Pay Matrix may also apply for the post. In case of selection of CCF against CF level, the pay shall be protected and the position shall be deemed to be supernumerary of the level of CCF till it is held by a CCF level officer.
- The post of DCF are to be filled up through officers of Indian Forests Services/State Forest Service in the Levels -10, 11, 12 and 13 of the 7<sup>th</sup> CPC Pay Matrix.

The IFS/SFS officers who are willing to <sup>be</sup> considered for appointment on deputation against these vacancies with liability to serve anywhere in India under the Council, are requested to send their applications through proper channel to the Secretary, Indian Council of Forestry Research and Education, P.O. New Forest, Dehradun-248006 (Uttarakhand). The application should be received by the Secretary, ICFRE on or before 10.10.2021 in the enclosed proforma and requisite non-refundable fee of Rs.500/- in the form of Demand Draft in favour of the Accounts Officer, ICFRE and payable at Dehradun.

6. The State/UT Governments are requested to send the Confidential Reports for the last five years (2016-17 to 2020-21) and vigilance clearance in respect of willing officers, while forwarding their applications.

7. The tenure of All Indian Service officer will be governed in accordance with the provisions under prevalent rules in this regard.


8. The officer on appointment on deputation to the council would get pay and allowances as per prevalent rules.
