No. 87.—His Excellency the Governor in Council is pleased to declare, under the provisions of section 16 of the Madras Forest Act (V of 1882), that from the 31st March 1886 the area, the boundaries of which are set forth in the schedule appended to this notification, will be constituted reserved forest :—
