No. 339.—In exercise of the powers conferred by section 5 of the Opium Act (I of 1878), and with the previous sanction of the Governor-General in Council, the Governor of Fort St. George in Council is pleased to direct that the following amendments shall be made in the rules under the said Act, published with his Notification No. 124, dated the 21st March 1903, namely :—

- (i) In rule I, clause (9), after the words "other than those used for smoking", insert the words "or of any quantity of morphia or preparations thereof not exceeding 10 grains."
- (ii) In rule III, clause (a), and in rule XX, after the same words add the words "but not being morphia or preparations thereof".
- (iii) After rule III, clause (a), add a new clause as follows, and re-number clauses (b) and (c) as clauses (c) and (d), respectively :—
 "(b) Any quantity not exceeding 10 grains of morphia or preparations thereof."
