#### Fort St. George, August 13, 1931.

No. 296.—The Governor in Council is pleased to declare under section 16 of the Madras Forest Act V of 1882 that the area the boundaries of which are described in the schedule below shall be constituted a 'Reserved Forest' with effect from 1st September 1981:—

#### SCHEDULE.

South Kanara district, Kasaragadtaluk.

[Number and name of the block—No. 220, Aletti East Extension Reserved Forests.]

#### BOUNDARIES.

North.—Starting from eairn No. 25-4 on the eastern boundary of Aletti East Reserved Forests, on the top of Rangathamalai peak, on the common boundary of Aletti village of Puttur taluk and Panathadi village of Ksaragod taluk (the meeting point of 'F' lines 451 and 5618;) north-east along the said common village boundary—('F' lines 5618 along the boundary of Aletti East Reserved Forest for a distance of 4,048 links to cairn No. 25 of the same reserved forest, 478 and 417). Thence south-east along the south-western boundary of Resurvey No. 332 of Panathadi village—('F' lines 94, 477, 92, 248, 222, 557, 468, 248, 603, 184, 157, 480, 104, 133, 145, 453, 600 and 685)—to the north-western corner of Resurvey No. 331 of the same village.

East.—Thence the western boundary of Resurvey No. 331 ('F' lines 137, 146, 293, 265, 126, 149, 203, 303, 167, 157 and 174) (crossing Kattaiyadichal at 144 links) to the northwesternmost corner of Resurvey No. 376; thence along the western boundary of Resurvey No. 376—('F' line 722) to the southernmost corner of the same survey field on the western boundary of Resurvey No. 335-8—("F" lines 331 and 200) (crossing Belthachar Halla at 50 links) to the common boundary stone of Resurvey Nos. 335-8, 336 and 317. The Kunnangad-Panathur footpath enters the reserved forest westwards at 22 links north of the trinjuction stone of Resurvey Nos. 335-8, 336 and 317. Thence southwards along the western boundary of Resurvey No. 317 (the Panathadi Reserved Forest ("F" lines 241 and 823). The Kunnangad-Panathur footpath leaves east wards the reserved forest at 298 links from the stone joining "F" lines 241 and 823 of Resurvey No. 317; thence westwards and southwards along the northern and western boundaries of Resurvey No. 329 ("F" lines 424, 238 and 166); the Belthachar Halla enters the reserved forest on the "F" line 238 at 70 links north of its southern extremity.

South.—Thence westwards along the northern boundaries of Resurvey Nos. 327-6 and 327-5—('F' lines 371, 81, 126, 265, 193 and 300); thence along the north-eastern boundary of Resurvey No. 326—('F' lines 212, 392, 300 and 67)—to the stone joining Resurvey Nos. 325 and 326; thence along the eastern boundary of Resurvey No. 325 ('F' line 853) to the north-enmost corner of Resurvey No. 325; thence a straight line southwest to the westernmost corner of Resurvey No. 325—('F' line 946); thence along the northern, western and southern boundaries of Resurvey No. 377—('F' lines 471, 492, 108, 124, 291 and 262)—to the trijunction stone of Resurvey Nos. 377, 325 and 326—('F' lines 340, 115 108, 405, 501 and 224) to the junction stone of Resurvey Nos. 324, 326 and 330 (Resurvey number of the reserve); thence along the northern boundary of Resurvey No. 324—('F' lines 496, 219, 272, 155, 232, 129, 385, 517, 346, 275, 230, 404, 451, 364, 234, 214, 331, 132, 660 and 450) to meet the village boundary (and taluk boundary) on the boundary line of Aletti East Reserved Forests.

West.—Thence northwards along the boundary line of Aletti East Reserved Forest (common boundary between Aletti village of Puttur taluk and Panathadi village of Kasaragod taluk)—('F' lines 344, 764, 249, 522, 125, 329, 308, 566, 339, 755, 289, 344, 646 and 451)—to the starting point.

#### ANNEXURE

The following public right of way to a width of 45 links open to men and cattle is admitted within the Aletti East Extension Reserved Forest.

The footpath from Kunnangad to Panathur.—It enters the reserved forests, westwards at 22 links north of Resurvey junction stone of Resurvey Nos. 335, 336, 317 and 330 in a south-westerly direction for a distance of about 5 chains and leaves the reserve eastwards at 293 links from the Resurvey stone joining 'F' lines 241 and 823 of Resurvey No. 317.

#### Fort St. George, August 7, 1931.

No. 297.—The Governor in Council hereby declares under the provisions of section 4 of the Madras Forest Act (V of 1882) that it is proposed to constitute the area, the boundaries of which are described in the schedule below, a 'Reserved Forest'.

#### SCHEDULE.

Kurnool district, Markapur taluk, Kolukula village.

Description and boundaries.—The area which is 168.20: acres in extent comprises resurvey No. 295 of Kolukula village and is bounded on all sides by the Eastern Nallamalai Block IX R.F.

2. The Governor in Council under clause (o) of the said section 4 of the same Act appoints the Revenue Divisional Officer, Markapur, for the time being to be the Forest Settlement Officer (1) to enquire into and determine the existence, nature and extent of any right claimed by, or alleged to exist in favour of, any person, in or over the lands comprised within the boundaries mentioned above, or of any alleged right, in regard to any forest produce in such lands and (2) to deal with such claims in the manner provided in Chapter II of the said Act.

The Governor in Council under section 4 of the Act appoints the District Forest Officer, Kurnool East Division, for the time being to attend on behalf of Government during the enquiry.

3. The Governor in Council under the authority vested in him by section 14 of the said Act appoints the Collector of Kurnool for the time being to hear appeals from the orders passed by the Forest Settlement Officer under sections 11, 12 and 13 of the same Act.

#### Fort St. George, August 11, 1931.

No. 298.—Under the provisions of section 1 of the Madras Cattle Disease Act, 1866, the Government, Ministry of Public Works, hereby direct that the provisions of the said Act shall be brought into force in the village of Kil Viraraghavapuram in the Tinnevelly taluk, Tinnevelly district, from the 1st to the 31st October 1931, both days inclusive.
