Whereas the Government of Kerala has published Act No. 21 of 2005, namely, The Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2005, which came into effect from 2nd day of June 2000 for the Conservation and Management of Ecologically Fragile Lands, minimising the reduction or degradation of the Eco-System and Biological Diversity therein.

Now it is hereby notified for the information of the public that the ownership and possession of the lands as per the details shown in the Schedule hereto, in the District of Palakkad have been vested with the Government of Kerala free from all encumbrances and the right, title and interest of the owner or any other person thereon shall stand extinguished from the date of commencement of the Act, i.e. 2nd June 2000.

The publication of this notification is made as required under section 3 (2) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2005 as per Government Notification No.15367/Leg. B1/01/Law dated 3rd May, 2005 and published in Kerala Gazette No. 329, dated 3rd May 2005.

The sale conditions published by the Chief Conservator of Forests, Thiruvananthapuram vide Notification No. Pro. (5)-5370/2005 dated 28.11.2005 in the Kerala Government Gazette No. 50 dated 20.12.2005 in pages 389 to 395 and other sale conditions prevalent in the Forest Department are applicable to this tender/auction sale. Any further notification to the sale conditions that may be ordered by the Government after the publication of this notification will also be applicable to this sale. If the notified date of tender/auction declared as a holiday, the sale will be conducted on the next working day and if the sale is not possible on the notification date due to other reasons, the same will be conducted on the alternate dates shown below at the same place and time. The intending bidders should satisfy themselves about the quality and quantity of the materials put up for sale before the commencement of the auction and any complaints whatsoever will not be entertained after the sale proceedings are over. In case, any Government Department requires any of the materials, the quantity remaining after their selection only will be auctioned. The quantity that may become ready for sale after the publication of this notification will also be included in this sale. The tender/auction will commence at the time notified in the schedule in the dumping site or the plantation in respect of jungle wood logs and will continue till the sale of materials listed for the day is over.
