NOTIFICATION

No. EFL 1-134/2006.

Whereas the Government of Kerala has published Act No. 21 of 2005, namely, the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, which came into effect from 2nd day of June, 2000 for the Conservation and Management of Ecologically Fragile Lands, minimizing the reduction of degradation of the Eco-system and Biological diversity therein;

Now, it is hereby notified for the information of the public that the ownership and possession of the lands as per the details shown in the Schedule hereto, in the district of Kannur, Kasaragod and Wayanad have been vested with the Government of Kerala free from all encumbrances and the right, title and interest of the owner or any other person thereon shall stand extinguished from the date of commencement of the Act, i.e. 2nd June, 2000.

The publication of this notification is made as required under section 3 (2) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003 as per Government Notification No. 15567/Leg. B1/01/Law, dated 3rd May, 2005 and published in Kerala Gazette No. 929 dated 3rd May 2005.
