ERRATUM NOTIFICATION

[UNDER SECTION 3(2) OF THE KERALA FOREST (VESTING & MANAGEMENT OF ECOLOGICALLY FRAGILE LAND) ACT, 2003]

No. EFL 10-40/2003.

26th May 2015.

An approximate extent of 3.94 Ha. of land in Survey Nos. 392/2D, 392/2A, 392/2F and 392/C of Delampady Village of Kasaragode Taluk was notified as Ecologically Fragile Land under Section 3(1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Land) Ordinance 2001 as per Serial Nos. 1 to 4 in the schedule of the Notification No. C6-21437/2000 dated 12-7-2001 published in Kerala Gazette dated 24-7-2001. On noticing certain errors in the above notification dated 12-7-2001 an Erratum Notification No. EFL 12-213/2006 dated 29-7-2006 was published in the Kerala Gazette dated 15-8-2006 correcting the total extent of the land as 1.58 Ha. in Survey Nos. 392/2D, 392/2B, 392/2F and 392/2E and also some corrections in the boundary descriptions. Again another Erratum Notification No. EFL 12-213/06 dated 1-11-2008 was published in the Kerala Gazette dated 25-11-2008 correcting the notified survey number as 392/2C instead of 392/2E and boundary description of notified EFL in Survey No. 392/2B.

As required under the Act, Survey and demarcation of boundaries of the notified EFL has been completed and the correct details of the EFL are notified as in the schedule below.

An approximate extent of 2.50 Ha. of land comprised in Survey No. 38/4 of Shornur II Village, Ottappalam Taluk was notified as Ecologically Fragile Land under Section 3(1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Land) Ordinance 16/2001 as per Serial Number 101 in the schedule vide Notification No. C4-21437/00 dated 20-10-2000 and published in Kerala Gazette No. 1 dated 2-1-2001. Later the extent has been corrected as 2.1030 Ha. and revised boundary descriptions notified vide Erratum Notification No. EFL 12-252/06 dated 28-12-2009 and published in the Kerala Gazette No. 4 dated 26-1-2010.

The Hon'ble EFL Tribunal Palakkad as per judgement dated 22-11-2012 allowed the OA 23/2009 that an extent of 2.1030 Ha. of the above notified land does not qualify the definition of Ecological Fragile Land as defined under EFL Act.

Hence it is hereby notified that the land in the schedule below is excluded from Ecologically Fragile Land.
