DE-NOTIFICATION

[UNDER SECTION 3(2) OF THE KERALA FOREST (VESTING AND MANAGEMENT OF ECOLOGICAL FRAGILE LAND) ACT, 2003]

No. EFL 10 -358/2014.

29th May 2015.

An approximate extent of 0.9024 Ha of land comprised in Survey No. 45/6A of Ongallur II Village, Ottappalam Taluk was notified as Ecologically Fragile Land under Section 3(1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance 16/2001 as per serial number 32 in the schedule vide Notification No. C4-21437/00 dated 12-7-2001 and published in Kerala Gazette No. 36 dated 11-9-2001.

The Hon'ble EFL Tribunal Palakkad as per judgement dated 18-7-2014 allowed the OA 28/2010 that an extent of 0.9024 Ha of the above notified land does not qualify the definition of Ecological Fragile Land as defined under EFL Act. Special Government Pleader (Forest), Ernakulam vide letter No. C1 (AR) Ref. No. 33/14 dated 3-2-2015 has opened that there is no scope for filing appeal against the order in OA 28/10.

Hence it is hereby notified that the land described in the schedule below is excluded from Ecologically Fragile Land.

Explanatory Note

An approximate extent of 200 Ha of land comprised in Survey No. 330/Pt Kunnathidavaka Village, Vythiri Taluk was notified as Ecologically Fragile Land under Section 3(1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance vide Notification No. C4-21437/00 dated 4-10-2000 published in Kerala Gazette No. 43 dated 31-10-2000 as Sl. No. 75.

On scrutiny of the above said notification under section 19(3)b of EFL Act, 2003 and Rule 20 of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Rule 2007, the Custodian, EFL as per order No. EFL 3. 1285/07 dated 23-6-2011, found that the total extent of land in RS No. 419 is 190.3840 Ha and an extent of 8.30 Ha included in the same does not qualify the definition of Ecologically Fragile Land as defined under Section 2 b (1) of the EFL Act 2003 and ordered to remove the same from the notification. Erratum Notification was issued vide Notification No. EFL 10-40/13 dated 23-2-2013 of Custodian, Ecologically Fragile Land and published in Gazette No. 14 dated 2-4-2013 correcting the extent of EFL in above survey number as 182.084 Ha after deducting the 8.30 Ha not qualifying as EFL. The above denotification is intended to clarify 8.30 Ha is denotified from 190.3840 Ha.

Explanatory Note

(This does not form part of the notification, but is intended to indicate the general purpose).

An appropriate extent of 0.70 Ha was notified as EFL under section 3(1) of the Kerala Forest (V/M of EFL) Ordinance 16/2001, vide notification No. C6-21437/2000 dated 20-10-2000 and published in Kerala Gazette No. 1, Volume 46 dated 2-1-2001 as Sl. No. 53. Following the procedure stipulated under Section 10(A) of EFL Act, an extent of 0.2050 Ha was denotified from EFL vide denotification No. EFL 10-358/14 dated 9-2-2015 and published in the Gazette No. 9 dated 3-3-2015. But on scrutiny of survey sketch prepared by the Assistant Director, Forest Mini Survey, Kozhikode the actual Extent available for denotification is only 0.1908 Ha. Hence extent of denotification area has to be corrected.

Erratum notification is intended to achieve the said purpose.
