An approximate extent of 2 Ha of land comprised in Survey No. 148/1B (R.S. No. 156/12) of Akathethara Village, Palakkad Taluk was notified as Ecologically Fragile Land under Section 3(1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance 8/2001 vide Notification No. C6-21437/00 dated 12-7-2011 published in Kerala Gazette No. 36 dated 11-9-2011 as Serial No. 1.

Following the procedure stipulated under Section 10(A) of the EFL Act, the Government as per Letter Nos. 14748/E2/12/F&WLD dated 7-2-2013 and 14749/E2/12/F&WLD dated 14-12-2012 have agreed to denotify 0.5547 Ha and 0.5587 Ha of land respectively from the original notification. Hence, it is hereby notified that the land described in the schedule below is excluded from the Ecologically Fragile Land.

DE-NOTIFICATION

[UNDER SECTION 3(2) OF THE KERALA FOREST (VESTING AND MANAGEMENT OF ECOLOGICAL FRAGILE LAND) ACT, 2003]

No. EFL 10-358/2014.

30th August 2014.

An approximate extent of 32.38 Ha of land comprised in Survey No. 175 of Kavilumpara Village, Vadakara Taluk was notified as Ecologically Fragile Land under Section 3(1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance 8/2001 vide Notification No. C4-21437/00 dated 4-10-2000 published in Kerala Gazette No. 43 dated 31-10-2000 as item No. 48.

The Hon'ble EFL Tribunal Kozhikode as per judgment dated 22-1-2011 in OA.6/2009 declared that an extent of 7.0214 Ha out of the above notified land does not qualify the definition of Ecological Fragile Land as defined under EFL Act and ordered to remove the land from said notification. Hence, it is hereby notified that the land in the schedule below is excluded from Ecologically Fragile Land.
