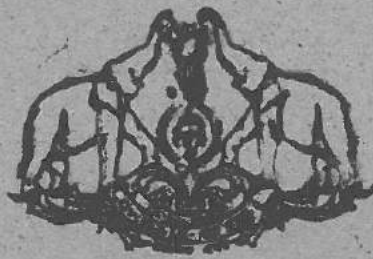

### NOTIFICATION

No. C4-21437/2000.

26th August 2000.

Whereas the Government of Kerala has promulgated an Ordinance No. 8 of 2000, namely, the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance, 2000 which came into effect from 2nd day of June 2000 for the conservation and management of Ecologically fragile lands, minimizing the reduction or degradation of the eco-system and biological diversity therein;

Now, it is hereby notified for the information of the public that the ownership and possession of the lands, as per the details shown in the schedule hereto, in the districts of Palakkad, Malappuram, Thrissur, Wayanad and Thiruvananthapuram have been vested with the Government of Kerala, free from all encumbrances, and the right, title and interest of the owner or any other person thereon shall stand extinguished from the date of commencement of the Ordinance, ie. 2nd June 2000.
