Whereas the Government of Kerala has published Act No. 21 of 2005, namely, the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, which came into effect from 2nd day of June 2000 for the Conservation and Management of Ecologically Fragile Lands, minimizing the reduction of degradation of the Eco-System and Biological Diversity therein.

Now, it is hereby notified for the information of the public that the ownership and possession of the lands as per the details shown in the Schedule hereto, in the District of Wayanad have been vested with the Government of Kerala free from all encumbrances and the right, title and interest of the owner or any other person thereon shall stand extinguished from the date of commencement of the Act, i.e. 2nd June 2000.

The publication of the notification is made as required under section 3 (2) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003 as per Government Notification No. 15567/Leg. B1/01/Law dated 3rd May, 2005 and published in Kerala Gazette No. 929, dated 3rd May 2005.

An extent of 3.3711 hectares of land in schedule (1) below was notified as Ecologically Fragile Land under section 3 (1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance 3/2000 as per Notification No. C4-21437/2000 dated 20-10-2000 and published in Kerala Gazette No. 1 dated 2-1-2001 under Sl. No. 102.

As per proceedings Order No. EFL6-4212/2005 dated 28-2-2007 of the Custodian, Ecologically Fragile Lands and Chief Conservator of Forests it is ordered to de-notify the said land from the purview of Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003. Therefore it is hereby notified that the land in Schedule (1) below is excluded from Notification No. C4-21437/2000 dated 20-10-2000.

Explanatory Note

An extent of 3.3711 hectares of land in Survey No. 69/1 of Thrikkedeen Village of Anaganmala locality of Ottappalam Forest Range of Palakkad Division, Palakkad Taluk in Palakkad District, was notified as Ecologically Fragile Land under Section 3 (1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance 3/2000 as per Notification No. C4-21437/2000 dated 20-10-2000 and published in Kerala Gazette No. 1 dated 2-1-2001 under Serial No. 102. This land was involved in OA 1003/75 of Forest Tribunal, Palakkad and was exempted and ordered to be restored. The notified area does not support predominantly natural vegetation and has only herbs and shrub growth with just one or two trees. Most of the property is plain land and hence does not come under the definition of ecologically fragile land. Hence it does not attract the provisions of Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003. As per letter No T. 1474/96 dated 2-2-2007 of Conservator of Forests, Eastern Circle, Olavakkode and as per the report of the committee, it has been reported that the area does not qualify to be vested under the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act and has recommended de-notifying the area.

Now, therefore it is hereby notified that an extent of 3.3711 hectares of land comprised in Survey No. 69/1 of Thrikkedeen Village of Anaganmala locality of Ottappalam Forest Range of Palakkad Division, Palakkad Taluk in Palakkad District notified as Ecologically Fragile Land vide Notification No. C4-21437/2000 dated 20-10-2000 and published in Kerala Gazette No. 1 dated 2-1-2001 under Sl. No. 102 shall stand deleted.
