Whereas the Government of Kerala has published Act No. 21 of 2005, namely, the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, which came into effect from 2nd day of June 2000 for the Conservation and Management of Ecologically Fragile Lands, minimizing the reduction of degradation of the Eco-System and Biological Diversity therein.

Now, it is hereby notified for the information of the public that the ownership and possession of the land as per the details shown in the Schedule hereto, in the District of Palakkad has been vested with the Government of Kerala free from all encumbrances and the right, title and interest of the owner or any other person thereon shall stand extinguished from the date of commencement of the Act, i.e. 2nd June 2000.
