Whereas the Government of Kerala has published Act No. 21 of 2005, namely, The Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, which came into effect from 2nd day of June 2000 or the Conservation and Management of Ecologically Fragile Lands, minimizing the reduction or degradation of the Eco-System and Biological Diversity therein.

Now it is hereby notified for the information of the public that the ownership and possession of the lands as per the details shown in the Schedule hereto, in the District of Palakkad have been vested with the Government of Kerala free from all encumbrances and the right, title and interest of the owner or any other person thereon shall stand extinguished from the date of commencement of the Ordinance, i.e. 2nd June 2000.

The publication of this notification is made as required under section 3 (2) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003 as per Government Notification No.15567/Leg. B1/01/Law dated 3rd May, 2005 and published in Kerala Gazette No. 929 dated 3rd May 2005.

It is hereby notified for the information of the public that the right of collection and removal of entire Cashew tree growth available in the area scheduled below will be sold on lumpsum basis by the Divisional Forest Officer, Thiruvananthapuram or his nominee at the Office of the Divisional Forest Officer, Thiruvananthapuram at 11 a. m. on 28-7-2006. If the notified day happens to be a holiday, the same will be conducted on the next working day at the time and place mentioned above. If the auction could not be conducted as noted above, the same will be conducted on 2-8-2006 at the same place and time without change of any of the conditions. The intending bidders are advised to inspect the area with the permission of the Range Officer, Palode Range before the sale and satisfy themselves of the area, quality and probable quantity of the produce in the area and the facilities for the transport of produce etc. No complaints of any sort about the area, extent, quality or quantity of produce etc. made after the sale will be considered.

Bidders should appear for the auction and produce a certificate of identification issued by the Village Officer in which Village the bidders are residing or such other valid documents. Nobody will be permitted to bid on behalf of another person unless valid power of attorney is produced.

The intending bidders should deposit Earnest Money of Rs. 10,000 in cash and sign in the copies of the sale notification having agreed to abide by the conditions of the sale. Any complaint raised afterwards in the matter will not be accepted. The successful bidder should remit 1/3 of sale price soon after the sale is knocked down in his favour. The period of contract is two months from the date of confirmation of the sale. The detailed sale conditions regarding the sale of Cashew trees are furnished in Kerala Gazette No. 16 dated 18-4-2006 (Pages 163 to 166).
