It is hereby notified for the general information of the public that Acacia timber collected from the Various Acacia plantations in Palode and Paruthipally Ranges of Thiruvananthapuram Division will be sold in tender/auction sale as per the schedule furnished below subject to the detailed Tender/Auction sale conditions published in Kerala Gazette No. 49 dated 14-12-2010 in Forest sheet Page No. 589 to 595 by Chief Conservator of Forests (Protection), Thiruvananthapuram, vide Notification No. Pro (5) 5628/2010 dated 2-12-2010 and other rules and conditions in force. Tender forms will be available in Divisional Forest Office, Thiruvananthapuram and Forest Range Office, Palode and Paruthipally on payment of ₹ 200 and VAT. Tenders will be accepted till the date fixed for tender/auction sale up to 9 a.m. in Range Office, Palode/ Paruthipally as the case may be. Tenders received after the stipulated date and time will not be entertained. If the date for Tender/Auction happens to a public holiday, harthal or strike, the auction sale will be held in the next working day at the scheduled time and place. Tenders will be opened immediately after the auction sale and further auction will be taken as per sale conditions. The intending bidders should satisfy themselves about the quantity and quality of the materials put up for tender/auction sale and no complaints will be entertained later on regarding the same. Further details of tender/ auction sale will be available from the Range Office, Palode and Paruthipally. Materials taken to stock up to the day before the auction will be included in sale and hence the quantity shown is approximate. If there is no bid or part bid in the 1st day of auction, the remaining materials will be put up for sale on subsequent dates and time shown in the schedule.
