An extent of 1.3840 Ha. of land in Survey No. 1/1, 54/1, 56/1, 56/2, 56/3 of Ottappalam II Village of Ananganmala Locality of Ottappalam Forest Range of Palakkad Forest Division Ottappalam Taluk in Palakkad District was notified as Ecologically Fragile Land under Section 3 (1) of Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance 2000 as per Notification No. C6-21437/2000 dated 12-7-2001 and published in Kerala Gazette No. 36 Volume 46 dated 11-9-2001 as Sl. No. 47 and was revised as 0.7275 Ha. (0.80 Ha. in Sy. No. 56/1pt, 0.3975 Ha. in Sy. No. 56/2pt and 0.2500 Ha. in Sy. No. 56/3pt) in Survey Number 56/1pt/ 56/2pt and 56/3pt of Ottappalam I Village as Sl. No. ECP-47 of Notification No. EFL10-100413/13 dated 28-1-2013 and published in Kerala Gazette No. 9, Vol. II dated 26-2-2013.

On scrutiny of the above said notification by the Custodian of Ecologically Fragile Lands as provided under Section 19(3) (b) of the Ecologically Fragile Lands Act, 2003 by following the procedure prescribed under Rule 20 of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Rules 2007, it was found that the area does not qualify the definition of Ecologically Fragile Lands as defined under Section 2b(i) of the Ecologically Fragile Land Act 2003 and therefore it is decided that the area has to be excluded from the Ecologically Fragile Land notification.

In the above circumstances it is hereby notified that the area notified against Serial No. 47 in Column No.1 of the Original Notification No. C6-21437/2000 dated 12-7-2001 and published in Kerala Gazette No. 36 Volume 46 dated 11-9-2001 and revised Notification No. EFL 10-100413/2013 dated 28-1-2013 and published in Kerala Gazette No. 9 Volume 2 dated 26-2-2013 as Serial No. ECP-47 is hereby excluded from vesting and the said notification stands amended to the above extent by invoking the powers conferred under Section 19(3) (b) of the Ecologically Fragile Lands Act 2003 with immediate effect.

## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

An extent of 1.3840 Ha. of land in Survey No.1/1, 54/1, 56/1, 56/2, 56/3 of Ottappalam II Village of Ananganmala Locality of Ottappalam Forest Range of Palakkad Forest Division, Ottappalam Taluk in Palakkad District was notified as Ecologically Fragile Land under Section 3(1) of Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance 2000 as per Notification No. C6-21437/2000 dated 12-7-2001 and published in Kerala Gazette No. 36 Volume 46 dated 11-9-2001 as Sl. No. 47 and was revised as 0.7275 Ha. (0.80 Ha. in Sy. No. 56/1pt, 0.3975 Ha. in Sy. No. 56/2pt and 0.2500 Ha. in Sy. No. 56/3pt) in Survey Number 56/1pt, 56/2pt, and 56/3pt of Ottappalam I Village as Sl. No. ECP-47 of Notification No. EFL10-100413/13 dated 28-1-2013 and published in Kerala Gazette No. 9, Vol. II dated 26-2-2013. The notified land does not come under the definition of Ecologically Fragile Lands as defined under Section 2(b) (i) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003. As per letter No. T-2367/97 dated 2-2-2007 of Conservator of Forests, Eastern Circle, Olavakode and as per the report dated 4-8-2006 of the committee which inspected the land, it has been reported that the land does not come under the definition of Ecologically Fragile Lands as defined under Section 2(b) (i) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003.

In the above circumstances this notification is issued to remove the said land from the original notification No. C6-21437/2000 dated 12-7-2001 and published in Kerala Gazette No. 36, Volume 46 dated 11-9-2001 as Sl. No. 47 and revised Notification No. EFL10.100413 dated 28-1-2013 and published in Kerala Gazette No. 9, Volume 2 dated 26-2-2013. against Sl. No. ECP 47 in Column No (I) and original notification is revised to that extent by invoking the powers conferred under Section 19(3) (b) of the Ecologically Fragile Lands Act with immediate effect. The above notification is intended to achieve the above purpose.
