Explanatory Note

An extent of 1.8120 Ha. and 0.8120 Ha. in Sy. No. 279/1 and 279/3 respectively of Thankamony Village, Idukki District was notified as ecologically fragile land vested with Government under section 3(1) of Kerala Forest (Vesting and Management of EFL) Act 2003, as per Sl. No. 57 and 59 in schedule of notification number EFL 12-35/2006 dated 26-7-2006, published in Kerala Gazette No. 33 dated 15-8-2006. Considering the application of the owners of the land, the Forest Tribunal, Kottayam as per judgement dated 6-4-2009 ordered that an area of 0.9022 Ha. in Sy. No. 279/1 and 0.7323 Ha. in Sy. No. 279/3 are not ecologically fragile land hence not vested with Government. The Government as per letter No. 4285/ E2/ 2012/F&WLD dated 15-5-2012 has directed to make necessary corrections in the notification published excluding earlier the areas not vested with Government. Hence the schedule as above showing net area to be retained as EFL after excluding the area not vested with the Government is published for the information of public.
