

The publication of the notification is made as required under Section 3(2) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003 published in Kerala Gazette No. 929, 3rd May 2005 as per Government Notification No.15567/Leg.Bl/0l/Law dated 3rd May 2005.
