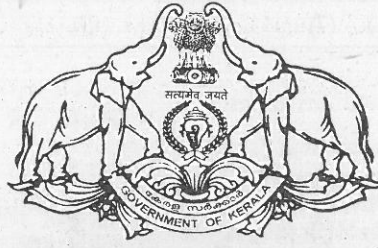

An extent of 5.740 Hectares of land described in the schedule below was notified as Ecologically Fragile Land under Section 3(1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance, 2000 vide notification No. C4-21437/2000 dated 20-10-2000 and published in the Kerala Gazette No. 1, Volume 46 dated 2-1-2001 as Sl. No. 29 & 31.

One Bojan s/o Kada Gowder, Katchikatti, Keelkuntha, Neelgiri District, Tamil Nadu and 9 Others filed EFL OA 18/2008 before the Hon'ble Tribunal for the Kerala Forest (Vesting and Management of Ecologically Fragile Lands), Palakkad for denotifying the area from EFL which was allowed in favour of the applicants vide judgement dated 30-11-2010. MFA 53/2011 filed by the State against the judgement dated 30-11-2010 in EFL OA 18/2008 was dismissed by the Hon'ble High Court of Kerala on 16-1-2012. SLP No. 11917/12 preferred by the State against the judgement in MFA No. 53/2011 also dismissed by the Hon'ble Supreme Court on 23-7-2012. Therefore it is decided that the area has to be excluded from the EFL notification.

In the above circumstances it is hereby notified that the area notified against Serial No. 29 and 31 in column No. 1 of the original notification No. C4-21437/2000 dated 20-10-2000 and published in Kerala Gazette No. 1 Volume 46 dated 2-1-2001 is hereby removed therefrom and the original notification is revised to the above extent by invoking the powers conferred under section 10(3) of the Ecologically Fragile Lands Act 2003 with immediate effect.

#### Explanatory Note

(This does not form part of the notification but is intended to indicate its general purpose.)

An extent of 5.740 Hectares of land in Survey No. S/D3, 4/2 of Pudur Village of Sootra locality of Attappady Forest Range of Mannarkkad Forest Division, Mannarkkad Taluk in Palakkad District was notified Ecologically Fragile Land under Section 3 (1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance, 2000 as per Notification No. C4-21437/2000, dated 20-10-2000 and published in the Kerala Gazette No. 1, Volume 46 dated 2-1-2001 as Serial No. 29 and 31. One Bojan s/o Kada Gowder, Katchikatti, Keelkuntha, Neelgiri District, Tamil Nadu and 9 Others filed EFL OA 18/2008 before the Hon'ble Tribunal for the Kerala Forest (Vesting and Management of Ecologically Fragile Lands), Palakkad for denotifying the area from EFL which was allowed in favour of the applicants vide judgement dated 30-11-2010. MFA 53/2011 filed by the State against the judgement dated 30-11-2010 in EFL OA 18/2008 was dismissed by the Hon'ble High Court of Kerala on 16-1-2012. SLP No. 11917/12 preferred by the State against the judgement in MFA No. 53/2011 also dismissed by the Hon'ble Supreme Court on 23-7-2012.

In the above circumstances this notification is issued to remove the said land from the original notification No. C4-21437/2000 dated 20-10-2000 and published in Kerala Gazette No. 1, Volume 46 dated 2-1-2001 as Serial No. 29 and 31 in column No. 1 and original notification is revised to that extent by invoking the powers conferred under Section 10(3) of the Ecologically Fragile Lands Act with immediate effect. The above notification is intended to achieve the above purpose.
