Explanatory Note

(This does not form part of the notification, but is intended to indicate the general purpose.)

The land as per the schedule above was originally notified under Section 3 (1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance 16/2001 vide Notification No. C6-21437/2000 dated 12-7-2001 and published in Kerala Gazette No. 36, Volume 46 dated 11-9-2001 as Sl. No. 85. But on scrutiny of the said notification by the Custodian of Ecologically Fragile Lands as provided under section 19(3) (b) of the Ecologically Fragile Lands Act, 2003 by following the procedure prescribed under Rule 20 of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Rules 2007, the area in Survey No. 60/2 is found predominantly supporting natural vegetation and naturally grown trees and it qualifies the definition of EFL as defined under section 2(b)(i) of Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003 and the area in survey No. 58/2 does not qualify the definition of Ecologically Fragile Lands defined in the act and its inclusion in the notification was inadvertent error. Thus certain error is seen crept in the notification in the name of locality, survey No. with sub division extent and Northern Boundary correct details in respect of the land notified as Ecologically Fragile Lands are shown in the revised schedule as above. Hence this Erratum Notification is published with the intention to achieve the above objective.
