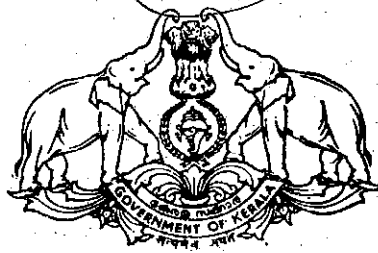

WHEREAS, the Government of Kerala has published Act No. 21 of 2005, namely, the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, which came into effect from 2nd day of June 2000 for the conservation and management of ecologically fragile lands, minimizing the reduction of degradation of the Eco-system and Biological Diversity therein.

Now, it is hereby notified for the information of the public that the ownership and possession of the land as per the details shown in the schedule hereto, in the District of Thrissur has been vested with the Government of Kerala free from all encumbrances and the right, title and interest of the owner or any other person thereon shall stand extinguished from the date of commencement of the Act, i.e. 2nd June 2000.

The publication of the notification is made as required under Section 3(2) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003 as per Government Notification No. 15567/Leg. B1/01/Law dated 3rd May 2005 and published in Kerala Gazette No. 929 dated 3rd May 2005.

Sealed tenders are invited till 3 p. m. on 20-1-2011 from approved Contractors for the following work by Wildlife Warden, Thiruvananthapuram Wildlife Division for and on behalf of Governor of Kerala. The tenders will be opened at 3.30 p. m. in the presence of the bidders present on that date. The tenders can be sent by post also well in advance so as to reach this office in time.

Name of work with Estimate Amount— Improvement of Peppara-Podiyam main road in Peppara Sanctuary— ₹ 3,00,000.

E.M.D.—₹ 7,500

Cost of tender form—₹ 600+ VAT.

Qualification of Contractor—3 years experience in Government or Quasi Government firm.

Period before which works is to be completed—60 days from the date of agreement.

The details and necessary documents will be obtained from the Office of the Wildlife Warden, Thiruvananthapuram on any working days till 1 p. m. of tender date. Tender form can be obtained by remitting cash including sale tax with necessary application. The cost of tender form will not be returned. The terms and conditions applicable to tender formalities in Kerala Public Works Department will be applicable to this work also. Tender forms are not transferable. G. O. (P) 84/97/P&T, dated 19-8-1997 related to PWD tender is also applicable here. The Earnest Money Deposit will be accepted only as Demand Draft from Nationalized or Scheduled Bank. The Earnest Money Deposit has to be pledged in the name of Wildlife Warden, Thiruvananthapuram and the name of work must be entered on it. A preliminary agreement in stamp paper worth ₹ 100 in prescribed form should also be submitted along with the tender. The tender without the preliminary agreement will be refused. The successful tenderer is liable to remit the taxes as per rules. If the tender date becomes holiday, the tender will be conducted on 27-1-2011.
