In view of the powers conferred by Section 3 (1) of Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, it is hereby notified for the information of the public that the following amendments are made in the details of Sl. No. 1 under column 7 and 8 of the notification published in reference No. EFL 1-134/2005 dated 14-8-2006 in the Kerala Gazette No. 37 dated 19-9-2006 as shown in the schedule attached.

#### Explanatory Note

The land under the above schedule was originally notified under Section 3 (1) of Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, as per Notification, No. EFL-134/2006 dated 14-8-2006, in the Kerala Gazette No. 37 dated 19-9-2006 as Sl.
