Explanatory Note

No. 27. In that Notification error was crept in survey number and boundaries. Bit-II was omitted in the earlier notification. Whereas as the correct details in respect of the land notified as ecologically fragile land are shown in the revised schedule as above. Hence this Erratum Notification is published with the intention to achieve the above objective.

It is hereby notified for the information of the public that the Teak Poles collected from the 1990 Teak Plantations Chengara-Anakuzhimon in Vadasserikkara Range of this division as shown in the schedule given below will be sold in public tender cum auction at dumping site shown in the schedule by the Divisional Forest Officer, Ranni or any other Officer authorized by him subject to the conditions published in Kerala Gazette No. 50 dated 16-12-2008 vide Notification No. Pro (5) 7698/08 dated 6-12-2008 of the Chief Conservator of Forests (P), Thiruvananthapuram and other conditions prevalent in the Forest Department.

Besides the quantity shown in the schedule, the quantity to be delivered to dumping site before the date of Tender-cum-Auction will also be included in the sale. If the date of tender-cum-auction noted in the schedule is declared as public holidays, the tender-cum-auction will be conducted in the next working day at the same time and place and if the proposed tender-cum-auction is not held due to other reasons, the same will be conducted on the alternate date as shown below at the same time and place. Tender forms can be had from this office on all working days on payment of Rs. 100 and VAT.

Officer authorised to receive tenders—Range Officer, Vadasserikkara.

Last date and time for receipt of tender—17-6-2009, 9 a.m.

Those who intent to participate in the tender-cum-auction shall deposit a sum of Rs. 20,000 (Twenty thousand only) as E.M.D. in cash at the time of submission of tender. Those who intend to participate in the auction above shall deposit the EMD at the above rate before the commencement of auction.

Intending persons may ensure the quantity and quality of materials put up for auction/tender and no complaints will be entertained after auction/tender. The tenderers/bidders should produce a certificate showing the permanent address and signature of the bidders duly attested by the concerned Village Officer, or any other approved identity documents before depositing the EMD. Those who do not produce any approved Identity Card or Certificate will not be allowed to participate in the tender/auction.

In case Government Department requires any of the materials, the quantity remaining after their selection only will be auctioned. The quantity that may become ready for sale after the publication of this notification will also be included in the tender-cum-auction. Any further notification to the sale conditions that may be ordered by Government after the publication of this notification will also be applicable for this tender-cum-auction.
