Whereas the Government of Kerala has published Act No. 21 of 2005 namely, the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, which came into effect from 2nd day of June 2000 for the Conservation and Management of Ecologically Fragile Lands, minimizing the reduction or degradation of the Ecosystem and biological diversity therein.

Now it is hereby notified for the information of the Public that the ownership and possession of the lands as per the details shown in the Schedule hereto, in the district of Idukki have been vested with the Government of Kerala free from all encumbrances and the right, title and interest of the owner or any other person thereon shall stand extinguished from the date of commencement of the Ordinance, i.e. 2nd June 2000.
