In view of the powers conferred by Section 3 (1) of Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, it is hereby notified for the information of the public that the following amendments are made in the details of Sl. No. 45 under column 9 and 11 to 14 of the notification published in reference No. C6-21437/2000 dated 12-7-2001 in Kerala Gazette No. 36 dated 11-9-2001 as shown in the schedule attached.

Explanatory Note

(This does not form part of notification but is intended to indicate the general purpose.)

The land as per the schedule attached was originally notified under Section 3 (1) of Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, vide Sl. No. 45 of Notification No. C6-21437/2000 dated 12-7-2001. In that notification, the Survey No. with Sub division and boundaries, were shown erroneously whereas the correct details are as given in the schedule. The erratum notification is intended to achieve the above objective.
