- S. R. O. No. 416/2014.—In exercise of the powers conferred by sub-section (1) of section 5 of the Kerala Preservation of Trees Act, 1986 (35 of 1986), the Government of Kerala hereby direct that no tree standing in the area specified in the Schedule below, shall be cut, uprooted, burnt or otherwise destroyed except on the ground that,—
 - (a) the tree constitutes a danger to life or property; or
 - (b) the tree is dead, diseased or wind-fallen.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The area specified in the schedule to the notification, a private Cardamom estate, is an enclosure within Reserved Forests which supports tree growth. Removal of the tree growth in the area will result in ecological imbalance. Therefore, in order to preserve the tree growth in the area, it is considered necessary to bring the area under purview of Section 5 of the Kerala Preservation of Trees Act, 1986.

The notification is intended to achieve the above object.
