## Explanatory Note

(This does not form part of the notification, but is intended to indicate the general purpose).

The land as per the schedule above was originally notified under Section 3 (1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance 8 of 2000 vide Notification No. C4-21437/2000 dated 20-10-2000 and published in Kerala Gazette No. 1 Volume 46 dated 2-1-2001 as Sl. No. 24. In that notification the extent was erroneously mentioned as 3.41 Ha. instead of 9.32 Ha. The correct extent of the property is shown in the revised schedule as above. The land falls in the newly constituted Kallamala Village, this change is also made in the erratum notification. The erratum notification is published with the intention to achieve the above objective.
