WHEREAS, the Government of Kerala has published Act No. 21 of 2005, namely, the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act 2003, which came into effect from 2nd day of June 2000 for the conservation and management of ecologically fragile lands, minimizing the reduction of degradation of the Eco-System and Biological Diversity therein.

Now, it is hereby notified for the information of the public that the ownership and possession of the land as per the details shown in the schedule hereto, in the District of Palakkad has been vested with the Government of Kerala free from all encumbrances and the right, title and interest of the owner or any other person thereon shall stand extinguished from the date of commencement of the Act, i.e., 2nd June 2000.

The publication of the notification is made as required under Section 3(2) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003 as per Government Notification No. 15567/Leg. B1/01/Law dated 3rd May 2005 and published in Kerala Gazette No. 929 dated 3rd May 2005.

But on Scrutiny of the above said notification by the Custodian of Ecologically Fragile Lands as provided under Section 19 (3) (b) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003, (Act 21 of 2005) by following the procedure prescribed for the same under Rule 20 of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Rules 2007, it was found that the said land does not qualify the definition of Ecologically Fragile Land as defined under Section 2 b (i) of the Ecologically Fragile Lands Act, 2003 and therefore it does not vest with Government as ecologically fragile land under Section 3 (1) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003.

In the above circumstances it is hereby notified that the area described in the above schedule and notified as serial number 33 in column Number (1) of the notification No. C4-21437/2000 dated 26-8-2000 of Principal Chief Conservator of Forests, Kerala and Custodian published in the Kerala Gazette No. 37 dated 19-9-2000 is hereby deleted there from and the Notification No. C4-21437/2000 dated 26-8-2000 is revised to the above extent by invoking the powers conferred for the same to the Custodian, Ecologically Fragile Lands under Section 19 (3) (b) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Act, 2003 with immediate effect.
