Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purpose.)

The land as per the schedule above was originally notified under Section 3 (3) of the Kerala Forest (Vesting and Management of Ecologically Fragile Lands) Ordinance 8/2000 vide Notification No. C4-21437/2000 dated 26-8-2000 and published in Kerala Gazette No. 37, Volume 45 dated 19-9-2000 as Sl. Nos. 49 to 53. Error had crept in the boundaries shown in the original notification and the survey numbers not furnished since this land was not surveyed at that time. Moreover Manalaroo-Pothupara Bit II and Manalaroo-Koonampalam Bit II were happened to be omitted in the original notification. The erratum notification is prepared based on EFL committee inspection on 27-12-2008. The above notification is intended to rectify the error mentioned herein.
